

Whistleblower protection and open data are unanimously recognized as key measures to deter and detect corruption in public procurement. Open data and citizen engagement are a way to contribute to enhancing a culture of accountability and transparency. Whistleblower protection is crucial to encourage the reporting of misconducts, fraud or corruption. Although the EU, OECD, the Council of Europe and NGOs at local and global level have recognized whistleblower protection and open data as key tools to address corruption and malpractices, there has been no assessment of the impact of these measures adopted by Member States or by EU Agencies.

This project addresses the need for assessing the impact of whistleblower legislation and open data policy on public procurement in seven Member States (Austria, Estonia, France, Ireland, Italy, Romania, and Slovenia) in order to develop an ICT tool for the public administrations (from local authorities to public companies) to self-evaluate their policies.



Target group: Public administration in partner countries (which could apply the ICT tool to self-evaluate their policies) and citizens (who will benefit in the long run from a more accountable public administration and will be contributing to this accountability, through an increased awareness of open data and transparency in public administration).



Framework Decision 2008/909 on the application of the principle of mutual recognition to judgments in criminal matters imposing custodial sentences or measures involving deprivation of liberty for the purpose of their enforcement in the EU

The project aimed to discuss the current bottlenecks in implementing the FD, build mutual trust between national authorities and identify a model of cooperation between the states involved (Romania, Italy and Spain) and set up a system of collection of quantitative and qualitative information on the transfers.

Justice, Anti-corruption and Good Governance

The project addressed the issue of the integration on the labor market of Roma youth by means of the national and EU funded Youth Guarantee schemes in three countries: Romania, Bulgaria and Hungary.

Main activities:

- Data collection and analysis requested from the regional and national Public Employment Services (PES) in all partner countries
- Designing of country studies based on preliminary research aimed at identifying institutional barriers and drivers, as well as good practices in each country, which could be further replicated and also mapping local stakeholders and national projects and programs for young NEETs
- Designing of a comparative study addressing best practice cases among EU Member States, focused on the integration of young NEETs from vulnerable groups in the framework of the Youth Guarantee
- Local, regional and national meetings with relevant stakeholders.



Target group: young NEETs (Not in Education, Employment or Training) from vulnerable groups from Romania, Bulgaria and Hungary; local and national PES representatives; local stakeholders, experts and relevant NGO representatives in the field of Roma youth issues.

Social Policies, Anti-poverty and Anti-discrimination

The project addresses the topic of high schools as community learning hubs with an active role in the development of small and medium farms and agricultural businesses, providing services for both youngsters and adults.

CRPE focuses on documentation and advocacy activities to ensure further premises for the sustainability of the program and for addressing the goal on a larger scale.

In addition, the project aims to stimulate and support stakeholders (both public and private) to be involved in the development of rural areas, particularly in the field of agriculture (in the 12 high schools included in the program and beyond them), by prioritizing agricultural education and establishing data-driven, coherent national strategies and programs in this respect.



Target group: 12 high schools with agricultural profile in Romania with an active role as community learning hubs for the development of small and medium sized farms and agricultural businesses; in addition to public and private stakeholders that can provide a continuation and implementation of the program.

The project was aimed at assessing the impact of small farmers' association in terms of gaining market access, developing economically and contributing to the preservation and flourishment of traditional rural livelihood in Romania.

CRPE was in charge of researching the implementation of the RAF pilot program, which included the creation of four agricultural associative structures, in each geographic area in Romania:

- •Legume de Vidra
- •Lunca Someșului Mic
- •Miere de Câmpie
- •Târgu Frumos

Moreover, the project was designed to contribute to tackling small farmers' limited access to capital and also to solutions for expansion, to increase their changes of development.

The project addressed the topic of civic mobilization and street protest as new forms of democratic participation, seeking to translate grassroot level messages and link them to EU public policies, favoring a bottom-up approach. closer to EU citizens.

Main results:

- An E-debate competition concerning the most important topics of debate at EU level in the framework of the EU elections, street protests and movements within the EU:
- 16 video stories the future of the EU with young participants in the street protests in Romania, Greece, Bulgaria and Germany:
- 6 town hall meetings in all partner countries that brought together more than 500 participants who debated the most recent trends and various forms of civic mobilization and their impact on the future of Europe:
- 4 position papers on the specific framework and evolution of civic mobilization in Romania, Bulgaria, Greece and Germany; in addition to 1 comparative report which provides recommendations for improving citizens' engagement and role in the future of the EU.

The project aimed to raise awareness and disseminate know-how among the youth on the importance of the EU 2019 elections and to empower youth and youth workers with the required tools to gain momentum and influence through interactive and user-friendly methods.

Main results:

- A guiz and an interactive E-debate competition that allowed user-friendly interaction with more than 500 youngsters and youth workers, promoting critical thinking and argumentative speeches
- 6 days training course in Brussels organized with youth from Romania and Greece, with the winners of the e-debate competition
- A guideline on lessons learnt on how to empower youth and inform them of the importance of EU elections and on how to combat online disinformation campaigns.

The project aimed at providing technical assistance to the European Commission Representation in Romania for the organization of national conferences, round tables and meetings, for the purpose of communicating and stimulating debates concerning the EU priorities, as well as giving rise to reactions and proposals in relation to European policies.

The project encouraged free discussions on European subjects of interest, generated by the current developments at political and institutional level, as well as those related to the economic, social and cultural dimension of the European phenomenon. Several longterm platforms for public debate have been produced, concentrated on Romania's role in the European Union.

These meetings helped create the necessary framework for a specialized analysis of the most important matters of the European context and for defining a Romanian view on the future European political and institutional architecture.

Main results: over 80 events organized, ensuring the thematic foundation and the related follow-up activities.

The project aimed to develop, deploy and maintain a transnational online platform in English, Bulgarian, German, Italian, Romanian and Czech in order to provide comparative legal and practical advice to the variety of professionals working with children-victims of crime on reinforcing the application of Directive 2012/29/EU and Directive 2004/80/EC.

In addition, the consortium elaborated a methodology aimed at individualized needs assessment of the child victims of crime and established a pan European network of multidisciplinary professionals working with child victims of crime.

REPORT.MD - CORESPONDENT EUROPA – Facts not Fake

The project tackled the matters of cybersecurity, fake news, political disinformation, and media propaganda, as well as ways for journalists to identify and eradicate these issues through a dedicated training seminar and a tailored study-visit in Romania. In addition, the project sought to raise awareness among the Moldovan public, in particular among young people, of the economic and social benefits (as well as prospects) that the country's democratic development and cooperation with the Western world and the European Union have brought via a dedicated storytelling campaign composed of 15 multimedia stories and 5 cross-border case studies. Subsequent to the project, a specialized report and training guide on propaganda patterns in the Republic of Moldova was developed.











Debate (EUROSFAT Forum): Can civic engagement influence the result of the European elections? (Bucharest)

Agricultural Advisory in Romania. Evolution and Public Policy Recommendations



The study aims to analyze the agricultural advisory system in Romania, starting from the most important legislative changes in its evolution after 1989 to its current organizational structure.

In addition, the study carries out a brief analysis of the models developed by other states in the field of agricultural advisory.

The analysis shows that, in Romania, the (re)construction of a functional and performing agricultural advisory system is an urgent matter, not only from the perspective of the farmers' needs for development, but also given Romania's access to future agricultural funds post-2020. Access of young vulnerable NEETs to Youth Guarantee measures in Romania. Current status and way forward



The report analyzes the implementation of Youth Guarantee program in Romania, its main objectives, target groups, national projects for young NEETs, and, above all, the extent to which the program managed to facilitate and to support the integration on the labour market of young people at risk of social marginalization – in particular Roma youth.

In addition, the study includes a series of public policy recommendations, targeting both the architecture and implementation of the future Youth Guarantee in Romania post-2020, as well as how the program could support the inclusion of young people from vulnerable groups into the labour market. The Youth Guarantee. Best practices in supporting young NEETs from vulnerable groups among EU countries



The research shows how the Member States have successfully implemented a variety of measures and programs focused on young NEETs as part of the Youth Guarantee.

Based on best practice cases identified among EU Member States, the study proposes a set of recommendations that aim to help improve the future implementation of the Youth Guarantee program, with a focus on vulnerable groups in countries such as Romania, where this target group still faces increasing cultural, societal and institutional barriers.


