I. CRPE - Romania

CRPE has a significant portfolio of transnational projects and regional projects in the field of good governance, justice and foreign affairs (including EaP and Western Balkans), social inclusion and anti-poverty, youth and civic participation, rural development, education and entrepreneurship, human rights.

Within our projects, we strive to address pressing issues at the local, national, and European level to support our target groups - from young people to relevant actors at the local or regional level, experts, local and central public authorities, etc.

This year, we adapted the CRPE activities to the current context of the Covid-19 pandemic and thus we managed to organize over 10 online debates, workshops, roundtables, training courses with relevant stakeholders at the local and national level, and to write over 8 policy papers that addressed current issues such as: judicial cooperation in criminal matters, fake news, propaganda and disinformation, anti-corruption, youth, civic activism, etc.

CRPE has been developing a strong in-house research capacity based on the permanent staff, benefiting from the expertise of its 13 staff members and over 15 affiliated experts.



Whistleblowing Open Data Impact. An Implementation and Impact Assessment (WOODIe)

Period of implementation: February 2019 - February 2021

The project focuses on the current implementation and impact of whistleblowing legislation and open-data policy in public procurement in seven EU Member States, in order to develop an ICT tool for the public administrations (https://www.woodietool.eu/) to self-evaluate their policies.

Target group: Public administrations (which could apply the ICT tool to self-evaluate their policies) and citizens.

Partners: Università degli Studi di Torino (Italy); Amapola – Progetti Per La Sicurezza Delle Persone E Delle Comunita Associazione (Italy); Université d'Angers (France); Vienna Centre For Societal Security – Vicesse, Wiener Zentrum Fur Sozialwissenschaftliche Sicherheitsforschung (Austria); Univerza V Mariboru (Slovenia).

Trust and Action - Judicial cooperation in criminal matters

Period of Implementation: October 2018 - October 2020

The project focuses on two acts concerning judicial cooperation in criminal matters in the EU: Framework Decision 2008/947/JHA on the application of the principle of mutual recognition on judgments and probation decisions and Framework Decision 2009/829/JHA on mutual recognition to decisions on supervision measures as an alternative to provisional detention. The project aims to build trust and devise best practices for better judicial cooperation between Member States by involving universities, iudicial experts and ministries of justice from Italy. Spain and Romania.

Target group: national authorities and practitioners in the field of justice from Italy, Spain, and Romania

The partners are the University of Turin (Italy), Amapola Progetti (Italy), University A Coruña (Spain), and the Italian Ministry of Justice (Italy).

Research and advocacy for positioning agriculture high-schools as hubs for small and medium farmers

Period of implementation: October 2015 - November 2021

The project aims to bring solutions for 50 high schools with an agricultural profile from Romania by improving teaching methods, connecting with the business environment, extracurricular activities, e-learning solutions, but also promoting agricultural activity of the high schools enrolled in the program. Within the project, CRPE interviewed over 120 students from agricultural high schools and designed an online platform (with over 2000 views) that includes relevant information and news in the field, but also a social media group to facilitate an informal forum of debates.

Target group: 50 agricultural high schools in Romania, public and private stakeholders at local and national level.

Project partners: Civitas Foundation, World Vision Romania, Junior Achievement Romania, Foundation Center Entrepreneurship and Executive Development in Romania (CEED).

The project is financed by Romanian-American Foundation (RAF).

YOUCooperATE: Youth Cooperation for Agricultural Renewal through Education



Period of implementation: March 2020 - August 2021

The project aims at consolidating the knowledge and capabilities of youth aged 15-17 years old engaged in agricultural education programs (T-VET), promoting formal and non-formal education opportunities, and best practices and tools on agricultural entrepreneurship. The project comprises modern teaching tools and e-learning methods to educate and encourage the development of the agricultural cooperative sector in the five countries of the project.

Target Group: T-VET Students aged 15-17 years old from Romania, Hungary, Bulgaria, Latvia, and Italy; T-VET education experts, agricultural cooperatives, researchers, decision-makers, representatives of the Government.

Project partners: National Institute for Cooperative Education - Irecoop (Italy), Civitas Foundation (Romania), National Union of Small Family Farmers and Producers Association NUSFFP (Bulgaria), Farmers' Parliament (Latvia), and National Agricultural Research and Innovation Centre NAIK (Hungary).

Common Agricultural Policy



COOP NET - Network of facilitators in the development of associative structures

Period of implementation: January 2017 - November 2021

The project aims to train a group of 80 people to set up sustainable structures for farmers and to help small producers provide market access for their products. Coop Net is a network that supports the association and collaboration between Romanian farmers. It does this by training stakeholders to create associative structures in the territory of the Local Action Group (LAG) in which they apply for funding.

CRPE is responsible for updating the comprehensive agricultural cooperatives data-base and highlighting the evolutions of the cooperative sector in Romania (quantitative parameters) since the last iteration (in 2016-2017), advocating for measures conducive to the development of new and existing agri coops within the National Strategic Plan 2021-2027, documenting the development of the food hubs model, communicating it to stakeholders and advocating the model for the National Strategic Plan 2021 - 2027.

Partners: Civitas Foundation, World Vision Romania, Junior Achievement Romania, Foundation Center Entrepreneurship and Executive Development in Romania (CEED), Community Safety and Mediation Center, Foundation for the Development of the Civil Society (FDSC).

The project is financed by the Romanian-American Foundation (RAF).

Education and Entrepreneurship



Period of implementation: September 2020 - August 2023



The project aims to strengthen competencies for social entrepreneurship of young people and youth workers by developing learning materials and involving them in learning activities. The project envisages the creation of a virtual platform that will enable young people to create a business plan with financial reports and to track economic records. The goal is to teach real-world business skills by simulating the processes and activities that occur in a real company and its relationships with other companies and institutions.

Target group: 60 young people (15-22 years old) who will develop their entrepreneurial skills, understand the role of social entrepreneurship and its benefits both for personal and social development.

Project partners: Center for Nonprofit Legislation (Romania), DIESIS COOP, and Meuccio Ruini Consortium (Italy).

NATO's response to the Covid-19 pandemic: How youth can understand NATO efforts and help fight propaganda

Period of implementation: September - December 2020

The COVID-19 pandemic accelerated disinformation campaigns targeting NATO and its member countries. Youth is one of the most vulnerable groups in this regard as they interact daily with web content that many times is harmful or fake. By informing youth on the positive contribution of NATO in the fight against the pandemic in the Black Sea Region, the project aimed to improve popular confidence in NATO.

The project envisages a set of interactive activities, among which a webinar and a set of videos with NATO representatives and experts in the field of communication and security during which youth have the opportunity to interact and ask more questions about NATO performances. Additionally, the project aims at designing two policy briefs and an online toolkit for deconstructing disinformation in the region. Finally, the project aims to engage youth through a quiz about NATO and the ongoing disinformation campaigns and how to protect against fake news.

-Target group: high school and university students from Romania and the Republic of Moldova.

A new narrative for Europe: Bringing more union into the European Union

Period of implementation: September 2018 - February 2020



Target group: young participants in the street protests; in addition to policy experts and local authorities from Romania, Greece, Bulgaria, and Germany.

Project partners: Institute for European Politics (Germany), National University of Political and Administrative Studies (Romania), Risk Monitor (Bulgaria), and Inter Alia (Greece)

Social and Anti-Poverty Policies



Let's make the Invisible Visible

Period of implementation: September 2020 - August 2023

The project focuses on the issue of vulnerable groups (taking up marginalized communities, discriminated women, Roma groups, migrants/refugees) that are facing multiple discrimination in the EU countries – the Czech Republic, Romania, Poland, Austria, and Slovakia. The project aims at increasing competences by testing innovative practices in the field of adult education and counseling (drama techniques and participatory coaching methods), and raising awareness of the phenomenon by creating video portraits of discriminated women.

Project partners: GIC NORA (Czech Republic), Peregrina (Austria), TRANSFER Slovensko (Slovakia), and Fundacja Kobieca (Poland).

E-Protect II: Enhancing the protection of children - victims of crime

The project is designed to build up on and expand the previous results of the E-PROTECT implementation through the Directive 2012/29 practical application and by raising awareness on children's rights granted by the act. The project is set to provide capacity building to professionals and improve the cooperation between competent authorities dealing with child victims. As a result, child victims of crime will be provided support, and also professionals, actively working in this field, will be empowered.

Target groups: child protection professionals (including lawyers, judges, prosecutors, law enforcement agencies, medical staff, psychologists, social workers, civil servants, and other experts), policy-makers, and the general public.

Partners: Law and Internet Foundation (Bulgaria), Defence for Children International (Italy), Italian Ministry of Justice (Italy), South East European Research Center (Greece).

II. CRPE - R. Moldova

In 2020, the Moldovan Branch of the Romanian Centre for European Policies continued to prioritize topics that responded to the needs of citizens, youth, and local civil society. Even though the pandemic context determined that our projects will be implemented mostly online, we focused on elaborating interactive activities and providing useful and timely content to our participants and the general public.

CRPE-R.Moldova tackled the globally renowned *infodemia*, discussed with youth from both sides of the Nistru river about stereotypes and the impact of recent history on their lives, and engaged in projects to bring visibility and know-how to local NGOs from Moldova. Online trainings, campaigns, workshops, papers, and art projects are only some of the activities we undertook this year at CRPE-R.Moldova.





Fostering cooperation in the Black Sea Region: Setting up a transnational civic situation room

Period of implementation: July 2020 - October 2021

The project sets up a functional civic situation room that puts together 18-20 experts from six countries to address potential threats to democracy and rule of law. The project entails creating a secured virtual space for discussions, encrypted communication, and capacity building for cyber-security experts, creating a knowledge repository, facilitating discussions, and setting up a rapid response mechanism.

Target group: experts - human rights lawyers, representatives of the NGOs, and civic activists from Romania, Ukraine, Georgia, Republic of Moldova, Bulgaria, and Azerbaijan.

Project coordinated by CRPE Romania. Project partner: Center for Criminal Justice and Security Studies

Transnistrian conflict in the eyes of youth through street art

Period of implementation: February 2020 - October 2020

The project encompassess an online training course on the Transnistrian conflict, the impact of mass-media and social media, the importance of civic activism and unconventional art in erasing stereotypes and furthering interactions between different communities. The participants joined a workshop on graffiti and painted two murals - one in Chisinau and one in Dubasari. The murals, located in school courtyards, reflected young people's ideas on unity and friendship between the people from the both sides of the river Nistru.

Target group: High school students from the Republic of Moldova, including the Transnistrian region.

The project is financed by the Black Sea Trust for Regional Cooperation.

Enhancing the capacity of the local civil society for monitoring local public authorities

Period of implementation: August 2020 - June 2021

The project seeks to improve the expertise and the capacity of the local civil society on the functioning and monitoring of public authorities, as well as methods to ensure promotion and visibility for NGO activities. A guide on local civic activism has been developed and comprises relevant legislation pieces, best practices on collaborations between public administration and civil society and tools for implementation of projects and initiatives at local level that can benefit the community. Productive training sessions on the functioning and transparency of public administrations were organized and allowed the participants to explore ways to monitor public authorities. As a result, the participants will conduct a three-month monitoring campaign of their local or central public authorities and present a monthly report on the main findings and recommendations.

Target group: local civil society from Cimişlia, Căuşeni şi Basarabeasca, and Report.md, experts in public administration, civic involvement, transparency from Romania and Moldova, public authorities.

Deconstructing and exposing Russian fake news campaigns and propaganda during the Covid-19 crisis in the Republic of Moldova and the broad Black Sea Region

Period of implementation: April - December 2020

The project aimed at deconstructing and countering fake narratives in the the Republic of Moldova and the entire Black Sea Region. Together with our partners, journalists from the Report.md media outlet, we published more than 10 explanatory investigative articles and interviews about COVID-19 experiences of health workers, public figures and regular citizens. We drafted two policy briefs in which we synthesized the main fake narratives and actors that spread disinformation in Moldova and in the wider Black Sea region, and one report in which we presented a close up on the presidential elections in the Republic of Moldova and the use of the pandemia motif to gain electoral support. We also designed an interactive map of the broad Black Sea region in which we compiled and categorized popular fake narratives, actors, and channels of propaganda in Armenia, Azerbaijan, Georgia, Ukraine, Moldova and Belarus. 

The efficiency of judicial cooperation in criminal matters in the EU

CRPE provides a case study that discusses extensively how Romania, Italy, and Spain put into practice the same three EU framework decisions related to the sentences of those convicted in other countries or alternative measures that apply to them. Together with practitioners, magistrates, and experts in judicial cooperation, the consortium sought to reveal what the limitations are, both in terms of intra-state and national cooperation, what obstacles face the magistrates in the proper use of these instruments, but also a set of proposals for improving the practical framework in the implementation of the framework decisions.



Disinformation and propaganda in the management of the COVID-19 crisis in the Republic of Moldova

The policy brief analyses the impact of COVID-19 related disinformation on individuals in the Republic of Moldova. It outlines the main geopolitical goals of Russia and China, how state and church officials enabled their propaganda, and how the predominantly Russian media contributed to their spread. It also shows how disinformation affects measures meant to control the pandemic, but also Moldova's relations with the EU, Romania and the breakaway Transnistrian region.




Bulgaria: Over 100 days of protests against corruption.

An overview on the 2020 anti-corruption protests in Bulgaria, the report presents to the Romanian public the political and social reality in neighbouring Bulgaria. The 2020 anti-government protest wave is even more critical in the margins of the Bulgarian parliamentary elections in April 2021. The report presents several insights from Bulgarian experts.

The report presents an overview of the disinformation campaigns and conspiracy theories popular in the six countries of the Eastern Partnership during the COVID-19 pandemic. We explored the main disinformation subjects, drivers, beneficiaries and target groups. The paper speculates on what the potential short term and long term consequences of disinformation could be on the societies' resilience overall, and, in particular, how it can affect the image of the European Union in the countries of the FaP.

The pandemic motif was indispensable in this campaign and the publication reviews the impact of the COVID-19 themes in the electoral campaign.




A Guide on Civic Activism

The evolution of agricultural cooperatives in Romania (2017–2020)

Since 2014, CRPE has been analyzing the development of the agricultural cooperatives sector in Romania with a focus on its dimension, performances, results and trends. For 2020, the study shows that only 49% of the Romanian coops are functional mostly in the cereal and large crops sector. In the meantime, the production, marketing and processing in the field of fruits and vegetables have registered a spectacular leap in the last 3 years.

NATO & Youth involvement in the Black Sea Region Current progress and recommendations

This paper provides an overview on NATO's take on the youth with a focus on two frontline member states – Romania and Bulgaria, and two NATO partner countries – Moldova and Ukraine. Countries from the Black Sea Region are exposed to the growing presence of the Russian Federation through election meddling, propaganda, and disinformation campaigns, as well as historical political and economic links. This exposure may pose a threat to democracy, the rule of law, citizens' liberties, and to security in the region. In the long run, it may also affect the citizens' overall perceptions of NATO and of the West, as a whole.
